BYLAW NO. 4-2014

A BYLAW TO PROHIBIT THE HARBOURING
OF SPECIFIC CLASSES OF ANIMALS.

The Council of the Town of Delisle in the Province of Saskatchewan enacts as follows:

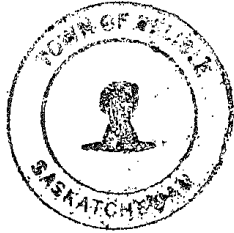
1. This bylaw shall be cited as the "Harbouring Bylaw".
2. "Harbouring" as defined in this bylaw shall mean any person giving refuge to or caring for an animal with the intent of keeping the animal for a term of longer than three days for whatever reason.
3. The following classes of animals are prohibited from being harboured within the corporate limits of the Town of Delisle:
 - a) All Arachnids dangerous to humans (such as scorpions and tarantulas, except tarantulas of the genera Aphonopelma, Avicularia and Grammostola);
 - b) All Artiodactylus Ungulates, including domestic goats, sheep and cattle;
 - c) All Bats;
 - d) All Canids, except the domestic dog;
 - e) All Crocodylians (such as alligators, crocodiles and caimans);
 - f) All Edentates (such as anteaters, sloths and armadillos);
 - g) All Elephants;
 - h) All Felids, except the domestic cat;
 - i) All Hyenas;
 - j) All Marsupials (such as kangaroos and opossums);
 - k) All Mustelids (such as skunks, weasels, otters and badgers) except the domestic ferret;
 - l) All non-human Primates (such as gorillas and monkeys);
 - m) All Perissodactylus Ungulates, including the domestic horse, mule and ass;
 - n) All Pinnipeds (such as seals, fur seals and walruses);
 - o) All Poultry, including chickens, ducks, geese and turkeys;
 - p) All Procyonids (such as raccoons, coatis and cacomistles);
 - q) All Raptors, diurnal and nocturnal (such as eagles, hawks and owls);
 - r) All Ratite Birds (such as ostriches, rheas and cassowaries);
 - s) All snakes of the families Pythonidae and Boidae;
 - t) All Swine (such as pigs, hogs and boars);
 - u) All Ursids (bears);
 - v) All venomous Reptiles and Amphibians;
 - w) All Viverrids (such as mongooses, civets and genet).

Examples of animals of a particular prohibited group are given in parentheses. They are examples only and shall not be construed as limiting the generality of the group.

4. The property owner will be personally responsible for all provisions of this bylaw and any person who contravenes any of the provisions of this bylaw shall be guilty of an offence and subject to the following penalties:

1st Offence - \$100.00
2nd Offence - \$200.00
Subsequent Offences - \$300.00.

5. The penalties referred to in Section 4 shall be reduced by 50% if paid within 7 days of issuance.
6. Bylaw No. 17-88 is hereby repealed.

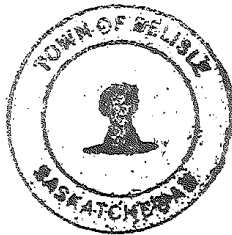
